44th EDITION OF THE INTERNATIONAL "MINICUADROS" CONTEST.

The Association HUESTES DEL CADÍ announces its WORKS OF ART IN SMALL FORMAT CONTEST according to the following rules:

1. Participation is open to artists of all nationalities.

2. There are 4 different awards:

Cadí award - €1,500

Libertad award - €1000

Salinas Packaging Group award - €1000

Junta Central award - €1000

The jury may grant other secondary awards with no endowment for those works whose quality deserves consideration. All prizes will be subjected to the current legislation in personal income tax withholding.

3. The maximum number of works per author is two.

4. Technique, subject and discipline are of free choice.

5. The size cannot exceed 25cm in any of its sides, including base, stand or frame. They must have a suitable base or stand and be devoid of glass.

6. Registration will be telematic. The participant artists must fill in the corresponding form in: <u>www.huestesdelcadi.es</u> from where there is access to the MINICUADROS contest link. Personal data as well as the work's details must be correctly typed. Keep the registration number after having completed the inscription.

7. Works can be shipped once the online inscription form mentioned in the point number 6 of the present rules has been submitted. They must have the information sheet provided in these rules filled in and attached on the back side. Then, they must be either sent in a prepaid freight safe package that preserves the works' intact conditions until their destination or handed in personally at the following address:

8. The term for the admission of the physical works is from the launch of these rules until 1:00 pm on Wednesday , 30th April 2025, at the Museo del Calzado.

9. A three member jury appointed by the contest director will choose a selection of works among which they will grant the different awards. All of them will be part of the present edition's catalogue and of the scheduled exhibitions.

10. The present edition's jury is formed by the following renowned professionals in art at national and international level:

PALOMA JARAMILLO, director of La Cometa Art Gallery, Bogotá, Miami, Madrid, Medellín.

PEDRO GALLEGO DE LERMA, director of La Gran Art Gallery, Madrid.

RAMÓN GARCÍA, director of th gallery My Name's Lolita Arts, Madrid.

May any member of the jury not be able to assist, the contest director, Lola González, will substitute.

11. The jury's decision will be final and made public only and exclusively on the Huestes del Cadí website from 12th May, 2025. It will include the awarded pieces as well as the ones selected for the exhibitions.

12. The awards ceremony will take place on Sunday 15th June 2025 at 12pm at the Museo del Calzado. Attendance is compulsory for the awarded artists residing in Spain.

13. The work awarded with the Cadí prize will become property of the Huestes del Cadí Association and the ones awarded with the other three prizes will remain property of their corresponding sponsors.

14. The selected works will be exhibited in the Museo del Calzado in June 2025, in Gabriel Poveda's exhibition room in Petrer in July, in Aspe's Museo Histórico in August, Setember and October and in the Arts Centre in Alicante in November.

15. The non selected works may be collected personally or by any authorized person from 15th June to 25th July 2025. The works whose autor marks the option of return by postal or delivery services will be sent back postage due in July. Both the awarded and the selected works will be withdrawn after the four scheduled exhibitions have finished.

16. The works sent back to their authors which are returned to the Museo del Calzado for reasons unrelated to the contest organization or the ones not collected personally, will become property of the Huestes del Cadí Association after three months, if they have not been claimed for.

17. The organization guarantees the utmost care in the treatment and custody of the works during the time they remain in its power, declining all responsibility for the imperfections or losses that may happen. The author, thus, renounces to any type of claim to the organization of the contest for the aforementioned concepts.

18. Participation in the contest implies the total acceptance and compliance with the present rules.

19. In compliance with the 15/1999 personal data Organic Law, the Huestes del Cadí Association informs that the data collected from the inscription form will become part of a file duly registered in the registry of the Spanish Data Protection Agency, owned by our association and will be exclusively used internally for this contest. In case of disagreement with any of the points above, please notify us in writing. Otherwise, we understand acceptance and consent for the expressed treatment.
